Thank you for your support of the Alliant Educational Foundation. Our most recent fiscal year has been highly successful, and we're delighted to share a few of this year's highlights in this brief report.

Among our many accomplishments, we're most proud of implementing a bold new strategic plan, re-tooling our Innovation/Seed Grants program to better reflect the mission and values of the Foundation, continuing to support hundreds of students through scholarships across the State of California, and expanding our regional Mental Health Consortium to better support under-resourced children and youth and their families.

As you may know, the Foundation was created in 2015 when Alliant International University converted to a public-benefit corporation, and the non-profit assets, including student scholarships, faculty research grants, and land ownership, were transferred to the new Foundation.

Since then, we've continued to partner with Alliant in a wide variety of ways. Over the past year, we've donated more than \$750,000 for student scholarships across the six Alliant campuses in California. We also served as the fiscal agent for faculty grants and contracts and launched our third round of innovation/seed grants.

Along the way, we continue to work closely with our donors – all of whom have entrusted us to invest their dollars wisely to support the students and programs that make Alliant such a special institution. Generous donors have helped us grow newer funds for long-term endowments as well as special memorial funds, whenever needed.

IMPACTING STUDENT LIVES

The Alliant Educational Foundation is helping drive student success by providing targeted scholarships to well-deserving students.

Over the past year, we have partnered with Alliant International University to fund \$750,000 in scholarships and tuition support, benefiting nearly 400 students across the six California campuses and the schools that comprise the Alliant educational system. In total, our donations now stand at nearly \$9 million over the past

seven years, helping thousands of students pursue their dreams of professional practice.

Additionally, the Foundation now manages approximately \$7 million in private endowment funds targeted to a variety of scholarships and programs. In the last year alone, the Foundation invested over \$200,000 in student scholarships from these endowments.

SUPPORTING FACULTY + STAFF THROUGH INNOVATION/ SEED GRANTS

As part of a project to foster innovative programs, research, publications, and enhancements within the Alliant system, the Foundation launched this program offering one-time funding for new initiatives proposed and led by current faculty and staff. This investment was for one-time “seed” funding to help launch new ventures and is available across the Alliant system to all campus locations and any school or department within the system.

In total, the Foundation awarded more than \$33,000 in grants to foster innovation and help launch five new faculty-led research and student advancement ventures at three of Alliant International University’s California campus locations.

From the many ideas submitted, the five projects selected by the innovation/seed grant review committee demonstrated a high level of commitment to improve learning environments for students and make positive impacts on communities at large, particularly in mental health, diversity and inclusion, and related to COVID.

A brief summary follows...



2022 INNOVATION / SEED GRANTS

TATIANA GLEBOVA, professor of psychology at the Sacramento campus, received a \$10,000 grant to organize the International Conference on Contextual Therapy in May of 2023. Contextual therapy's core principles and practice aim to strengthen fair interconnectedness, trustworthiness and accountability. The conference will be an international forum promoting ethics of care and social justice and will bring scholars and clinicians around the world together.

DUMAYI GUTIERREZ, assistant professor of psychology at the San Diego campus, received a \$8,500 grant to study minority stressors, ambiguous loss of safe spaces, and explore experiences of Black, Indigenous, People of Color, Lesbian, Gay, Bisexual, Transgender, Queer, Plus (BIPOC LGBTQ+) communities amid the COVID-19 pandemic.

NOAH HASS-COHEN, professor of psychology at the Los Angeles campus, received a \$5,025 grant to evaluate and provide critical postventions for long-term survivors of family suicide during and in the aftermath of COVID-19 surges, which undermine coping and resiliency.

RENEH KARAMIANS, assistant professor of psychology at the Los Angeles campus, received a \$5,800 grant to create a Sports Concussion Clinic that will provide a neuro-psychology practicum for first year Clinical PsyD students at the Los Angeles campus where students can learn to use basic neuro-psychological instruments to assess mild traumatic brain injury (concussion) cases and have the opportunity to write basic neuro-psychological reports.

MOJGAN KHADEMI, professor of psychology and **THADDEUS CAMLIN**, assistant professor of psychology at the San Diego campus, received a \$4,000 grant to expand the Joanne E. Callan Center for Applied Psychology & Services (CAPS) clinic to address the rise in demand related to substance use related issues with affordable long-term psychodynamic psychotherapy to individuals in the greater San Diego community, and to teach/train doctoral students in clinical psychology and conduct clinical research.

RESPONDING TO COMMUNITY NEED

As part of our strategic plan, the Foundation believes it has a unique opportunity to help leverage specific strengths of students and faculty to support a broader impact in the communities where we live and work.

MENTAL HEALTH CONSORTIUM

Working closely with Alliant's California School of Professional Psychology (CSPP) in San Diego, the Alliant Educational Foundation is building new bridges in support of children's mental health. At present, we're partnering with a variety of San Diego-based non-profit organizations who work with under-served infants, children, and young adults and their families.

The needs are great. We know from The Annie E. Casey Foundation's Kids Count Survey that children 3-16 with anxiety or depression jumped 70% in California between 2016 and 2020 – *and this data does not even include the adverse effects the pandemic had on the mental health of children and youth.*

By placing CSPP clinical psychology graduate students at these agencies, we're bolstering their capacity to provide high-quality mental health support to some of the populations who most desperately need it, while also providing invaluable training opportunities for CSPP-SD students. In addition, we are helping to fill the gap in the mental health workforce in San Diego County which is expected to reach a staggering deficit of 18,000 professionals by 2027.

DR. JEFFREY TIRENGEL MEMORIAL STIPEND FOR COMMUNITY MENTAL HEALTH

As a founding board member of the Alliant Educational Foundation, past member of the Board of Trustees with Alliant International University, and beloved faculty member for CSPP-Los Angeles, we recognize Dr. Jeffrey Tirengel's tremendous leadership and support to both the Foundation and CSPP. The **Dr. Jeffrey Tirengel Memorial Stipend for Community Mental Health** was launched in 2020 to enable students participating in the Mental Health Consortium to benefit from a modest monthly stipend to support their work with under-served children and youth.

In our third year (2022), 14 students were placed at six of the youth- and family-serving agencies listed below, providing services to an estimated 160 clients and their families benefiting from their professional services across the region.

By just the middle of the year, 546 treatment sessions had been provided, of which 83% were individual sessions, and 17% were group sessions.

At mid-year, a total of 82 unduplicated clients had received services at no cost, of which:

- 82% were children/youth ages birth to 24
- 18% were adults 25 and older
- 81% were black, indigenous, or people of color (BIPOC)
- 56% were female, 37% were male, and 7% were non-binary or unknown
- 77% had experienced one or more adverse childhood experiences (ACEs)

Beginning in the fall of 2021, the Foundation began sponsoring grand rounds which afford participating students and their agencies greater training opportunities and collaboration between students and sites.

Current and new participating agencies include:

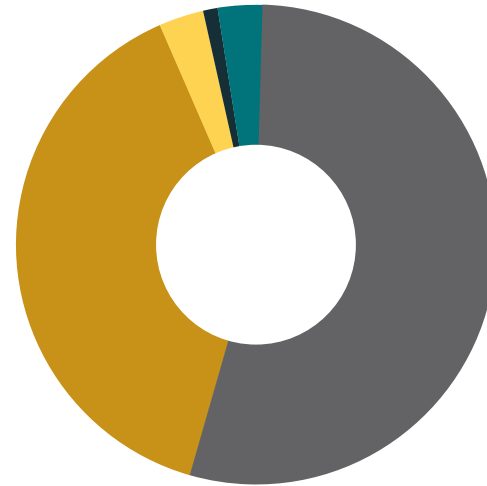

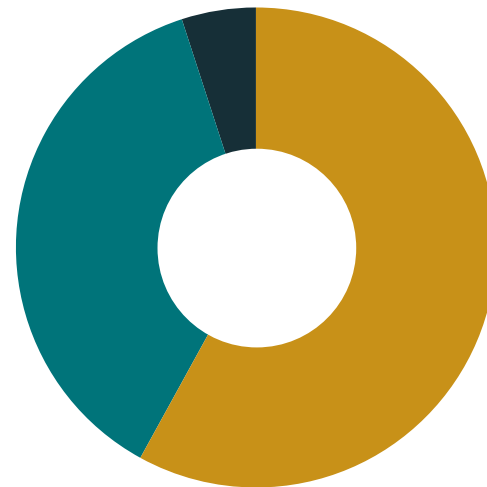
